## CHAPTER V CONCLUSION AND SUGGESTION

## **5.1 Conclusion**

The results of the data found in this research are 30 data containing 3 main topics of discussion, which are hegemony, counter-hegemony and domination. Hegemony consists of four parts, the first is the hegemony of power with the results of 3 data, ideological hegemony with the results of 9 data, moral hegemony with the results of 2 data, and cultural hegemony with the results of 3 data. Based on the data analysis in Chapter 4 in this research, the actor who practices the process of hegemony is often carried out by Caesar as the ruler, whether it is giving hegemony to his fellow herds or to humans. In addition, there is also Malcolm as the human actor in this movie who is the lower class where he receives the results of the practice of hegemony. However, it is also common for him to practice hegemony. This proves that there is no class gap in the movie Dawn of the Planet of the Apes because they can both give and receive the results of hegemony equally.

The second discussion point is counter-hegemony. Counter-hegemony is often practiced by Koba as the antagonist in this movie, but it is not uncommon for other apes to resist a certain policy. They carry out various kinds of resistance ranging from low to high impact, as evidenced by the analysis data found, such as humanistic resistance with a total of 2 data, passive resistance with a total of 2 data, and lastly, violent resistance with a total of 3 data. As an antagonist, Koba fights consciously from the lowest to the highest without caring about the risks he will

receive later, because it is a result of what he really questions in a particular policy and disagrees with it.

The final discussion point is domination with a total of 6 data results found. In regards to the previous explanation of counter-hegemony, this domination is practiced by Koba as the main character who dominates. This is the result of the counter-hegemony that he did before where he still disagreed with a policy and thus, he made a new revolution/power by creating domination. The form of power that Koba exercised was violence and oppression against humans, even against his own herd.

## 5.2 Suggestion

There is indeed nothing perfect in this world because the researcher realizes that this research is still far from perfection, where there are still many human errors and other errors, be it typing, discussion, or the results themselves. Even so, the researcher hopes that the results of the research that has been carried out can be a reference for readers in researching the same material topic or research object. The researcher hopes that this research can provide additional understanding about the existence of a designation related to a group that has power using ideology and intellectual property, which is hegemony, where it can occur to anyone without being well realized. In addition, the dominance of power is basically through violence and oppression in groups so that readers can identify and know the terms of both ways of exercising power. The researcher wants to prove and give some examples of how the upper class interacts with the lower class and how the upper

class, as the ruler, exercises its power while still having to consider policies to be appropriate so that there is no resistance that can produce something terrible such as a breakup in the power group. Furthermore, the suggestions given to other researchers are that they must understand sufficiently related to the focus of the study to be examined by reading more literature studies and understanding the data sources obtained during the research. Moreover, researchers must focus on one goal of what is being researched so that the discussion does not get out of line or divert in order to keep the content of the research appropriate and measurable. Apart from that, the researcher also hopes that the object of this research can be further studied from a different perspective so that this object can be studied more thoroughly.
