ABSTRACT

This study is entitled The Analysis of Post Traumatic Stress Disorder of The Main Character in The Movie All The Bright Places by Jenniver Niven. The study aims to identify the causes of post-traumatic stress disorder (PTSD) in main character, the symptoms of PTSD (Post Traumatic Stress Disorder) in main character and the way the main character recovered from her trauma.
